

INVITATION FOR PREQUALIFICATION

Total E&P Cooperative (TEPNG COOP) wishes to invite reputable and competent construction firms to express interest for the Construction of Proposed Recreation Centre at Plot 8, Trinity Avenue, Oniru, Lagos.

Scope of Works

- 1. Construction of Clubhouse fitted with gym, kitchen, restaurants, bars amongst others
- 2. Swimming pool
- 3. Sporting facilities
- 4. External works and infrastructures
- 5. Mechanical, electrical & plumbing installations

<u>Prequalification Requirements</u>

In order to be considered for pre-qualification, a contractor will be required to provide the following documents:

- 1. Evidence of Registration with the Corporate Affairs Commission (CAC) with the inclusion of Certificate of Incorporation and Articles of Association.
- 2. Current Company Tax Clearance Certificate corresponding with the company annual turnover for the last three (3) years.
- 3. Possession of experience as a Prime Contractor in at least (2) projects of similar nature and complexity with verifiable letters of contract award and certificates of job completion within the last Five (5) years.
- 4. VAT Registration with TIN number and evidence of VAT remittances for the last 3years.
- 5. Company's Audited Accounts for the last three (3) years.
- 6. Detailed Company profile and Organization structure including names and telephone numbers of key personnel (Technical/Managerial).
- 7. List of plants/equipment with proof of ownership/lease.
- 8. Evidence of company registration with relevant professional body in Nigeria.

Submission of Documents

- 1. The applicant should a create main folder named after the firms' name in the following format. e.g. "John Engineering Limited_TCOOP_Construct_Prequal"
- 2. The applicant should create five (5) subfolders in the main folder and name in the following order:
 - Statutory
 - Work experience
 - \circ Tax
 - Financial
 - Technical

- 3. Item 1 in "Prequalification requirements" above should be placed in Statutory subfolder.
- 4. Item 2 & 4 in "Prequalification requirements" above should be placed in Tax subfolder.
- 5. Item 3 in "Prequalification requirements" above should be placed in Work experience subfolder.
- 6. Item 5 in "Prequalification requirements" above should be placed in financial subfolder.
- 7. Items 6,7 & 8 in "Prequalification requirements" above should be placed in Technical subfolder
- 8. The main folder with all five (5) subfolders and attachments should be submitted via email attachment to: tender@totalupstreamng.coop
- 9. The total size of email attachment should not exceed 130mb
